

Gottlieb Mayer World War I Draft Registration Card

At 32, Gottlieb Mayer was one year older than the upper age of the first WW I Selective Service registration on 5 June 1917. However, on 12 Sep. 1918 he became part of the third registration of men aged 31-45. Note his actual signature on the card, and the fact that he was then still using his birth spelling of Meyer.
